January 5	All University offices and buildings reopen
January 11	Residence halls open
January 12	Spring Term enrollment period ends for all students
January 12	Spring Term classes begin
January 19	Dr. Martin Luther King's birthday observance (University closed)
January 23	Spring Term add/drop period ends. Last day to add/drop a class with no record on transcript.
January 24	Spring Term extended drop period begins; a proposed drop must be approved by the student's academic advisor and cannot reduce the student's credit load below 12 credits.
January 30	Spring Term extended drop period ends
January 31	Last day to apply for April 2026 graduation; a late fee will be assessed for applications received after this date
January 31	Monitored Withdrawal period begins; instructor must approve a class withdrawal beginning on this date
February 2	Summer term advising appointments begin
February 2	Spring Early Progress Reports open
February 6	Last day to exercise credit/audit grade option (contact the Office of the Registrar)
February 13	Summer Term enrollment appointments begin (Veterans)
February 16	Summer Term enrollment appointments begin (Non-Veteran students)
February 17	Spring Early Progress Reports close
March 2	Spring midterm grade rosters open at 9:00am
March 2	Fall term advising appointments begin
March 7	Residence halls close at 12:00 noon for Spring Recess
March 8-15	Spring Recess for students (no classes); all University buildings and offices will remain open and staffed except on Spring Holiday
March 13	University's observance of Spring Holiday (University closed)
March 15	Residence halls reopen at 12:00 noon
March 16	Spring midterm grade rosters close
March 20	Monitored Withdrawal period end. Last day to withdraw from a course; a "W" grade will be assigned on the transcript
March 21	The Director of Academic Advising will approve course withdrawals beginning this date through the end of the term <u>only</u> in exceptional circumstances
March 21	Last day to resign from the Spring Term with a prorated tuition charge; thereafter, tuition charge is 100%
March 20	Fall Term enrollment appointments begin (Veterans)
March 23	Fall Term enrollment appointments begin (Non-Veteran students)
April 4	Fall Term open enrollment period begins
April 17	Honors Convocation
April 24	Last session for all day classes (Monday-Friday) except for makeups
April 25	Reading Day for all day classes
April 25-May 2	Evening and Saturday classes will continue to meet during this period and final exams will be held during the last scheduled class meeting
April 27-May 1	Final exam period for all day classes
May 2	Spring Term ends: Official date for degrees awarded in spring term
May 2	Residence halls close at 12:00pm
May 2	Commencement
May 5	Final grades must be marked "approved" by instructors by 12 noon before final grade posting can begin

*Failure to attend a class does not constitute an official resignation. Students are not automatically dropped when they do not attend classes. Students can drop classes during the Add/Drop and Extended Drop periods designated above. Students can withdraw from a course (with instructor's signature) until March 20, 2026. Failure to drop or resign means that the student will be financially responsible for all courses. Students who do not drop, withdraw, or resign by the deadlines listed above may receive "F" grades in their courses.

The Pitt Greensburg Registrar reserves the right to make changes as are deemed necessary with the exception of those dates that appear in the University of Pittsburgh Academic Calendar.
